SUBJECT: New Office of the Police and Crime Commissioner Website

#### SUMMARY:

The Office of the Police and Crime Commissioner for Norfolk (OPCCN) has sought to commission the design, build and maintenance of a new website as the existing OPCCN website no longer fulfils the requirements of the office/PCC.

The role of the OPCCN is varied and constantly evolving with many strands and a large amount of information which must be shared with the general public.

The OPCCN's new website will provide residents/partners with easy access to information about the office and the role of the PCC, decisions which have been made and latest news in an accessible way.

The OPCCN's new website will also allow for new areas of the website to be added when needed.

A total of £14,970 excluding VAT (£17,964 Inc) will be provided to Bigfork, to develop and implement the new OPCCN website.

Ongoing annual hosting and support costs of £1,616 excluding VAT will be incurred (based on a three -year support contract).

Bigfork are a Norfolk-based marketing and web design company.

#### RECOMMENDATION:

It is recommended that the PCC for Norfolk supports the allocation of funding to Bigfork to

develop and implement the new OPCCN website.

#### **DETAIL OF THE SUBMISSION**

#### 1. OBJECTIVE:

1.1 To approve funding to develop and implement a new OPCCN website.

#### 2. BACKGROUND:

- 2.1 The Office of the Police and Crime Commissioner for Norfolk (OPCCN) has sought to commission the design, build and maintenance of a new website as the existing OPCCN website no longer fulfils the requirements of the office/PCC.
- 2.2 On advice from Norfolk Constabulary's procurement team, the OPCCN invited four local companies to put forward their proposals based upon the specification for the new website created by the OPCCN website team. Of these four companies, three companies expressed an interest and pitched their ideas and proposals to the website team and a member of Norfolk Constabulary's procurement team during January 2020.
- 2.3 Following the three proposal/pitch meetings, Bigfork appointed as provider for the website.

### 3 AREAS FOR CONSIDERATION:

- 3.1 Bigfork will create a new website ensuring:
  - The new design is professional, engaging and friendly
  - Design works well across all devices e.g. smartphones, tablets, laptops, desktop PCs
  - Functionality caters to the existing and future needs of the organisation
  - Content which showcases both the work of the PCC and that of the OPCCN
  - Compliance with transparency and accessibility requirements
  - Improved structure, navigation and search facilities to ensure content can easily be found
  - Consideration of the different user journeys for different audiences
  - Easy to access news and updates
  - A document library that can be easily searched and filtered.

- 3.2 Reassurance has been sought that Bigfork can work to the required 12-week timeline. A project plan has been supplied.
- 3.3 Reassurances have been sought that Bigfork can meet all elements of the OPCCN specification.
- 3.4 The OPCCN's newly developed branding and logo will be incorporated within the web design.

## 4 OTHER OPTIONS CONSIDERED:

4.1 Not funding the project. This option has been rejected due to the necessity to have an OPCCN website fit for purpose.

#### 5 STRATEGIC AIMS/OBJECTIVE SUPPORTED:

5.1 The OPCCN is required to publish information under the Freedom of Information Act 2000.

#### **6 FINANCIAL AND OTHER RESOURCE IMPLICATIONS:**

- 6.1 A total of £14,970 excluding VAT (£17,964 Inc) will be provided to Bigfork, to develop and implement the new OPCCN website.
- 6.2 Ongoing annual hosting and support costs of £1,616 excluding VAT will be incurred (based on a three -year support contract).
