# **SUMMARY:**

- 1. The current Joint HR Section 22A Collaboration Agreement expires 31 May 2022.
- 2. Renewal of the Section 22A Collaboration Agreement is presented for PCC consideration and approval.
- 3. The function, now referred to as "Joint People Directorate", continues to operate and deliver in line with strategic objectives and a further Collaboration Agreement is proposed to continue with the function for a further 5 years.

#### **RECOMMENDATION:**

It is recommended that the Chief Executive of the Office of the Police and Crime Commissioner is authorised to execute the collaboration agreement on behalf of the Police and Crime Commissioner, to enable the Joint People Directorate (formerly Joint HR) function to progress.

# **DETAIL OF THE SUBMISSION**

#### 1. OBJECTIVE:

Signing of the Joint People Directorate (formerly Joint HR) Section 22A Collaboration Agreement is requested by the Norfolk and Suffolk Chief Constables and OPCCs to enable the function to continue to operate within the current model.


# 2. BACKGROUND:

Both Norfolk and Suffolk Chief Constables and OPCCs agreed to collaborate under a Section 22A agreement with a Joint HR function in June 2017 in the interests of efficiency and effectiveness.

In accordance with Section 12 of the Collaboration Agreement, the function has been reviewed to ensure it continues to operate effectively and in accordance with organisational objectives. A new Collaboration Agreement for a period of 5 years is now proposed.

#### 3. AREAS FOR CONSIDERATION:

The creation of the Joint Shared Services Transaction Centre function in October 2020 subsumed the people transactional responsibilities formerly undertaken within HR. This required realignment of the remaining HR functions to form a revised structure now comprising Learning & Development, Resourcing & Recruitment, HR and Workplace Health, Safety & Wellbeing, with the function headed by a Director of People reporting into the Portfolio Leads, the Deputy Chief Constables of Norfolk and Suffolk acting jointly:



The process to secure a police staff Joint Director of People is underway and it is anticipated that the post will be filled by Summer 2022.

#### 4. OTHER OPTIONS CONSIDERED:

The Joint People Directorate function aligns to Norfolk and Suffolk Constabularies' values of transparency, public service, impartiality and integrity, the delivery of a modern, efficient, effective and innovative service with the right resources and good stewardship of taxpayers' money.
