SUBJECT: Collaboration Agreements - ERSOU, RIPA and ECTIU

SUMMARY: At the Eastern Region Alliance Summit on 10 October 2016 the renewal and refresh of the collaboration agreements concerning Eastern Region Special Operations Unit (ERSOU), Regulation of Investigatory Powers Act (RIPA) and Eastern Counter-Terrorism Intelligence Unit (ECTIU) was agreed. Approval is sought for the execution of the collaboration agreements to be undertaken. The parties to the agreements are the Police and Crime Commissioners and Chief Constables for the police areas in the Region (Bedfordshire, Cambridgeshire, Essex, Hertfordshire, Norfolk and Suffolk) and Kent.

RECOMMENDATION:

It is recommended that approval be granted to enter into renewed and refreshed collaboration agreements concerning ERSOU, RIPA and ECTIU.

DETAIL OF THE SUBMISSION

1. BACKGROUND:

- 1.1 At the Eastern Region Alliance Summit on 10 October 2016 the renewal and refresh of the collaboration agreements concerning ERSOU, RIPA and ECTIU were considered.
- 1.2 In October 2010 the first ERSOU Collaboration Agreement was signed. On 15 December 2011 an Addendum to that Agreement was signed clarifying the RIPA provisions.
- 1.3 The current ERSOU Collaboration Agreement was signed by the Regional Chief Constables and Police & Crime Commissioners on 23rd July 2014; this Agreement formalised the transfer of Lead Force responsibilities from Hertfordshire to Bedfordshire.
- 1.4 The current CTIU Collaboration Agreement was signed by the Regional Chief Constables and Police & Crime Commissioners on 23rd July 2014; this Agreement formalised the transfer of Lead Force responsibilities from Hertfordshire to Bedfordshire.
- 1.5 In April 2015 it was agreed across the Region that Kent Police could join any of the ERSOU capabilities they wished to join. Kent have subsequently given formal notice to the South East Regional Organised Crime Unit that they will be withdrawing from their current Collaboration Agreement as of 31 March 2017.
- 1.6 In November 2015 the Office of Surveillance Commissioners (OSC) inspected Bedfordshire, Hertfordshire and Cambridgeshire in terms of their arrangements for implementation of and compliance with Parts II and III of the Regulation of Investigatory Powers Act 2000 and Part III of the Police Act 1997. In addition the OSC examined the ERSOU Collaboration Agreement with regard to the provisions for cross border covert activity and authorisation.
- 1.7 The OSC commented that the existing Section 22 Agreement for ERSOU contained the necessary agreements enabling cross border authorisations for any investigation across the six constituent forces. Whilst it was clear that the Agreement was not exclusively for ERSOU investigations they recommended that it may now be appropriate to extract that section into its own Agreement.
- 1.8 As a consequence of these matters three new Collaboration Agreements have been circulated for consideration of execution:
 - The ERSOU Agreement has been re-drafted to include Kent Police. This has required only minor changes. The document is similar to that signed in July 2014. The RIPA and Police Act section is no longer included.
 - A new RIPA S22 Agreement has been drafted which incorporates the legislative terms and the operational practices. The document has been

- scrutinised by the relevant OSC Inspector. He is content that the draft addresses the issues he has raised.
- A new ECTIU Collaboration Agreement has been drafted to reflect the collaboration of all seven force (ie the Region and Kent) CT resources with the regional CTIU to create a single regional CT structure, overseen by Bedfordshire Police as Lead Force.
- 1.9 The draft ERSOU agreement has been reviewed by the legal services teams in all 7 forces and takes into account and reflects all feedback received. Much of the ECTIU agreement content is in effect a mirror image of the ERSOU agreement.
- 1.10 The ERSOU and RIPA Agreements will 'commence' on the date of signing which will be 10 October 2016. The ECTIU Agreement reflects and will facilitate new areas of change; the full collaboration of all force counter terrorism and domestic extremism resources into a single command. The 'commencement date' of the ECTIU Agreement will therefore be 1st April 2017 in order that the necessary HR processes and associated staff consultation can take place.
