DECISIONS

1. Agenda Item 7 – Police and Fire Collaboration: Fire and Rescue Service Use of OCC Offices and Control Room

The PCC approved the granting of the new licence agreement on the basis of the Heads of Terms detailed in the report.

The term will commence from the date of the agreement until 31st March 2026 and no rent or service charges will be payable by Norfolk Fire and Rescue Service (NFRS). NRFS will pay the capital cost of any building alterations and IT infrastructure

BACKGROUND

- 2. Norfolk Constabulary and Norfolk Fire and Rescue Service (NFRS) formed a Joint Partnership in 2014 with three agreed strategic aims:
 - to create a safer Norfolk.
 - to achieve greater operational effectiveness by reducing the need for service and protecting frontline resources, and
 - to identify efficiency savings.
- 3. A full update on collaborative activity was presented to the Strategic Governance Board on 27 October 2016. Both services are sharing accommodation and have achieved efficiencies, although small at this stage, from joint working. For example, the Constabulary is now making use of the NRFS North Lynn vehicle workshop. The rent of £10,500 has been waived and vehicles no longer have to be driven to Wymondham for servicing.
- 4. The move of Fire Control to co-locate with the Constabulary Control Room is a significant step towards much closer working between the two services, with further potentially significant efficiencies possible in the medium term.
