Summary:

- This Decision Notice seeks approval by the PCCto agree to Contract Variation Number 10 (No 7F-2020-0273) from 1st January 2024 for the Norfolk Integrated Domestic Abuse Service (NIDAS).
- This Decision Notice details changes in the Partnership arrangements for service delivery within the seven districts of Norfolk, between Tier 1 (the Contract Holder) Leeway Domestic Abuse and Violence Services and the Tier 2 partner the Daisy Programme

Detail of the submission

- 1. Objective:
- 1.1 To ensure that there is consistent delivery of the NIDAS service to cover the seven districts within in the County of Norfolk (Broadland, Breckland, Gt Yarmouth, Kings Lynn and West Norfolk, Norwich, South Norfolk and North Norfolk) that is in line with the original tender specification and contract award of the NIDAS Service.
- 2. Background:
- 2.1 The NIDAS contract was awarded to Leeway Domestic Violence and Abuse Services as lead agency after a competitive tender process in June 2021 which was managed by the 7Force Procurement Department.
- 2.2 Mobilisation of the service took place during October December 2021 with the service going live 3rd January 2022.
- 2.3 Leeway Domestic Violence and Abuse Services is the Contract holder (Tier 1) for the NIDAS Service and the original delivery partnership (Tier 2 Partners) consisted of the Daisy Programme, the Pandora Project, Safe Partnerships and Orwell Housing.
- 2.4 During the early stages of the service, the Pandora Project and Orwell Housing left the partnership and the NIDAS service was delivered by the Daisy Programme, Safe Partnership and Leeway Domestic Abuse and Violence Services who temporarily covered the areas that were originally serviced by the Pandora Project and Orwell Housing.
- 2.5 The current partnership has now reviewed the NIDAS Service delivery and through the Contract Variation process managed by 7Force Procurement Services, has proposed a change in the allocated districts for the current partnership so as to provide a consistent service but keeping in line with the original tender and Contract award.

- 2.6 The proposal by Leeway Domestic Abuse and Violence Services is as follows:
- a. Leeway Domestic Abuse and Violence Services delivery areas consists of, Broadland, Norwich, Great Yarmouth and South Norfolk districts.
- b. The Daisy Programme delivery areas consist of, Breckland, North Norfolk, Kings Lynn and West Norfolk districts.
- 2.7 The Office of the Police and Crime Commissioner is lead commissioner for the NIDA Sservice in partnership which consists of Adult Social Services, Childrens Services, Broadland District Council, South Norfolk District Council and Norwich City Council. All partners contribute funding to the NIDAS Service.

3. Areas for consideration:

- 3.1 That the service remains within the specification of the tender and Contract award of a 60/40 split between lead and local partners.
- 3.2 That service delivery to victims of domestic abuse is consistent across districts and in standards.

4. Other options considered:

4.1 The Contract holder looked at the option of another delivery organisation who could delivery to the specification of the Contract to join the partnership. This option did not come to fruition.

5. Strategic aims/objective supported:

- 5.1 The PCChas a statutory obligation to set out Police and Crime objectives through the Police, Crime and Community Safety Plan 2022-2024. The PCCs six priorities fall into the following categories each with detailed objectives in the plan:
 - Sustain Norfolk Constabulary
 - Visible and Trusted Policing
 - Tackling Crime
 - Prevent Offending
 - Support Victims
 - Safe and Stronger Communities
- 5.2 The NIDAS service supports two of these pillars: Supporting Victims and Safe and Stronger Communities.

- 5.3 The primary statutory legislation that drives the commissioning of domestic abuse services across the Local Authority and Police force areas are:
 - Crime and Disorder Act 1998
 - Domestic Violence, Crime and Victims Act 2004
 - Children Act 1989 & 2004
 - Health and Social Care Act 2012
 - Public Services (Social Value) Act 2012
 - Equality Act 2010
 - Directive 2012/29/EU of the European Parliament establishing minimum standards on the rights, support and protection of victims of crime Directive 2012/29/EU
 - Code of Practice for Victims of Crime MoJ Victims Code 2020
 - Home Office Violence Against Women and Girls Strategy
 - Tackling Violence Against Women and Girls July 2021
 - Domestic Abuse Act 2021
