# **Summary:**

- 1. This Decision Notice seeks approval by the PCCto agree to funding by way of a Grant Agreement to the Sue Lambert Trust (SLT).
- 2. Under this Grant Agreement SLT will be able to sustain and enhance its group programmes.
- 3. This Grant will allow the SLT to provide this specialist support to those victims/survivors in Norfolk.
- 4. SLT will provide group work to clients to enable them to cope and recover from the trauma that they have experienced.

#### Detail of the submission

#### 1. Objective:

- 1.1 To provide group programmes to victims/survivors of sexual abuse/violence/child sexual abuse, both recent and historic incorporating those with protected characteristics, ensuring that clients receive the best possible care and support.
- 1.2 The group programmes will be available to women and men aged 18 and over, free of charge in Norfolk.

#### 2. Background:

- 2.1 Under the Ministry of Justice Victims' Fund, each PCC area receives a Grant to support victims of crime based on a population formula generated by ONS date from mid 2020.
- 2.2 This award is made to the PCCarea in exercise of the power conferred on the Ministry of Justice by section 56(1) of the Domestic Violence, Crime and Victims Act 2004.
- 2.3 Activities under this Fund must satisfy the requirements of the Victims' Code and domestic Law and must:
  - Meet the support needs of Victims of Crime
  - Act in the interests of Victims of Crime supported
  - Be free of charge
  - Be confidential
  - Be non-discriminatory (including being available to all regardless of residence status, nationality and citizenship)
  - Be available whether or not a crime has been reported to the police
  - Be available before during and for any appropriate time after any investigation or criminal proceedings.
- 2.4 This Grant will cover the period of 1st April 2025 -31st March 2026

#### 3. Areas for consideration:

3.1 The service delivered by the Sue Lambert Trust must complement and work with other commissioned specialist services for victims/survivors of sexual abuse/violence/rape across the county to ensure coverage, choice for victims and localism. These services include:

- a. Brave Futures, delivering a service for Children 11+ across all districts of Norfolk.
- b. The Harbour Centre Norfolk's Sexual Assault Referral Centre (SARQ).
- c. Norfolk's Independent Sexual Violence Adviser (ISVA) service.

#### 4. Other options considered:

4.1 Not to fund – this was rejected as this would put victims/survivors at greater risk.

#### 5. Strategic aims/objective supported:

- 5.1 The PCChas a statutory obligation to set out Police and Crime objectives through the Police, Crime and Community Safety Plan 2025-29. The PCCs three priorities fall into the following categories each with detailed objectives in the plan:
  - Preventing crime
  - Cohesive communities
  - Reducing harm
- 5.2 This Grant will support one of these pillars: Reducing harm
- 5.3 The primary statutory legislation that drives the commissioning of domestic abuse services across the Local Authority and Police force areas are:
  - Crime and Disorder Act 1998
  - Domestic Violence, Crime and Victims Act 2004
  - Children Act 1989 & 2004
  - Health and Social Care Act 2012
  - Public Services (Social Value) Act 2012
  - Equality Act 2010
  - Directive 2012/29/EU of the European Parliament establishing minimum standards on the rights, support and protection of victims of crime Directive 2012/29/EU
  - Code of Practice for Victims of Crime –MoJ Victims Code 2020
  - Home Office Violence Against Women and Girls Strategy
  - Tackling Violence Against Women and Girls July 2021
  - Domestic Abuse Act 2021

#### 6. Financial and other resource implications:

6.1 The Total of the Grant Value is £30,000 (thirty thousand pounds)
