**SUBJECT:** Extension of Grant for: Independent Domestic Violence Adviser (IDVA) Service for Norfolk

Leeway Domestic Abuse and Violence Service

#### **SUMMARY:**

This service specification is for an IDVA service for high risk male and female victims of domestic violence and abuse aged 16 years and over in Norfolk.

The IDVA service forms part of a whole system response to domestic abuse, including identification, referral and triage, support provided to victims and post intervention step down and/or recovery.

Independent Domestic Violence Advisors (IDVAs) are professional case workers who support 'high risk' victims of domestic abuse and their children. The full definition as published by 'Safelives', states:

The provision of the IDVA Service covers victims and survivors of domestic abuse in Norfolk. The service has been in place for three years and supports victims of high risk domestic abuse cases referred through the Multi Agency Safeguarding Hub.

The existing service has been in place for three years since 2015. Under Clause 48 of the Grant Agreement and Contract Variation Form No 1, there is option to extend this grant by a further two years. The PCC has decided to exercise this option and extend this Grant for by a further two years covering 2018/19 to 2019/20.

In addition to the above extension and based on evidence of need, the PCC has also agreed to extend the service by a further 2 x IDVA fulltime posts and 1 x Part time Administrative Post as per Contract Variation Form Version 2. These posts will run concurrent in length to the main Grant.

**RECOMMENDATION:** It is recommended that the PCC for Norfolk agrees to the extensions of the Grant Agreements as laid out in Grant Variation No 1 and No 2.

#### **DETAIL OF THE SUBMISSION**

#### 1. OBJECTIVE:

To provide a service that supports high risk male and female victims of domestic violence and abuse for those aged 16 years and over in Norfolk.

#### 2. BACKGROUND:

Independent Domestic Abuse Advisers (IDVA's) is the professional name for a case worker who specialises in supporting victims/survivors of domestic abuse victims and whose primary purpose is to address the safety of 'high risk' victims and their children. Serving as a victim's main point of contact, IDVAs normally work with their clients from the point of crisis to assess the level of risk, discuss the range of suitable options and develop coordinated safety plans.

IDVAs are pro-active in implementing safety plans, which include practical steps to protect victims and their children, as well as longer-term solutions. These plans will include actions from the Multi-Agency Risk Assessment Conference (MARAC) as well as sanctions and remedies available through the criminal and civil courts, housing options and services available through other organisations. IDVAs offer independent support and work over the short- to medium-term to put victims on the path to long-term safety.

Safelives (previously known as Co-ordinated Action Against Domestic Abuse (CAADA)) believes that IDVAs are most effective as part of an IDVA service and within a multi-agency framework. The IDVA's role in all multi-agency settings is to keep the client's perspective and safety at the centre of proceedings.

High risk domestic abuse victims identified by frontline agency professionals (such as police, health or refuge workers) are referred to IDVA services in their locality. Victims may also self-refer to the IDVA service. Occasionally MARACs may refer victims to the IDVA service if contact with the victim has not already been established.

Domestic abuse is an under reported crime and it is recognised that the true extent of unmet demand is not fully understood. However, it is recognised, that most people who suffer domestic abuse will have endured many episodes of abuse before they seek help or support. It is therefore, important that agencies and support services do all they can to create an environment that encourages reporting.

In Norfolk the IDVA Service has 10 countywide case workers who support victims of domestic abuse. This has recently been extended by a further 2 IDVA's to cope with the additional demand that has steadily increased over the last three years in response to a variety of Domestic Abuse awareness campaigns, such as the DA Champion scheme.

### 3. AREAS FOR CONSIDERATION:

The service will form part of a whole-system response to domestic abuse, including identification, referral and triage, support provided to victims, Multi Agency Risk Assessment Conference (MARAC) and post-intervention step down and recovery to improve the experience of families impacted by domestic abuse. Although the service will not work directly with children under the age of 16, it will work closely with the relevant safeguarding agencies regarding children at risk of harm.

The outcomes that we commission against are:

- · Victims are safer and better resourced to stay safe
- · Victims have increased access to justice
- Victims report improved health and wellbeing
- An increased proportion of victims access community based support services
- Victims and their children are identified early by a wide range of partner agencies
- All identified victims are offered an equal and accessible service that best meets their needs
- Children at risk are identified and referred appropriately.

The key values underpinning the provision of the IDVA service are:

- Inclusive service
- Understand that all victims are unique and have different needs
- Fair access and equal treatment for all
- Commitment to quality
- Commitment to continuous improvement and evidence-based practice, including gathering, listening and responding to, user feedback
- Commitment to make the best possible use of resources and achieving value for money for victims and the wider public

- Police and Crime Plan 2016-2020
   Strategic Aim -Support victims and reduce vulnerability

- Home Office strategy to end violence against women and girls (VAWG) 2016-2020
- Norfolk's County Community Safety Partnership Priority- tackles domestic abuse and sexual violence

#### 7. OTHER IMPLICATIONS AND RISKS:

Domestic abuse incidents reported by the Office of National Statistics (ONS) for the county of Norfolk during 2014/15 was 12,481.

In 2016/17, a total of 15,793 domestic abuse incidents were reported by the ONS. This equates to an increment of 3312 domestic abuse incidents reported over a three year period and increment of 26.5%.

Support required by the IDVA service has also grown exponentially and therefore the extension in the number of IDVA's through Grant Variation No 2 addresses the risk of the number of cases being managed by the IDVA's in line with Safelives recommendations of safe working practices.

The administrative worker post addresses the risk of increased administrative work through the Domestic Violence Disclosure Scheme (DVDS) often called 'Clare's Law'.

The original term for this grant agreement was advertised as 3 years, with the option to extend for a further 2 years. Clause 48 of the grant agreement refers to this option, although it does not specifically detail it. Therefore this variation notice number 1 is to address this omission as is stated below.

It is hereby agreed, that at the end of the original 3 year term on the 31<sup>st</sup> March 2018, the OPPCN has the option to extend this grant agreement for a further maximum 2 year period, based on annual increments.

This extension is based on the understanding that all current Leeway IDVA staff members who have undertaken Safelives accredited training remain qualified until the end of this extension period. Also, all future Safelives IDVA training delivered to staff from 1<sup>st</sup> April 2018- 31<sup>st</sup> March 2020 will be subject to a revised training agreement including a pro rata requirement to pay back a percentage of overall training cost should staff leave within two years of completing the training.

This extension is at the discretion of the OPPCN providing the user requirements are being met and satisfactory funding is available.
