Safer Norfolk Foundation Medium Grant Programme – First Round of Grant Awards

SUMMARY:

In January 2014, the Police and Crime Commissioner (PCC) launched the Safer Norfolk Foundation Medium Grant Programme (Decision Report 2013/31 refers) working with the Norfolk Community Foundation, as one of the ways to deliver grants to organisations in support of the Police and Crime Plan Objectives.

The first round of bids was invited from charities, voluntary and community organisations across Norfolk asking them to demonstrate how they could help reduce crime and support victims in their local area.

- A total of 42 bids for funding were received and on 1st May 2014.
- The Safer Norfolk Foundation Panel met to review each application against the PCC's priorities.
- The funding pot was originally set at £100,000.
- Due to the exceptional standard of applications, the Independent Panel recommended the PCC to fund all organisations that met his Priorities.
- This will require an increase of £80,803 in funding to enable a total of £180,803 to be allocated to 25 groups.

A breakdown of the funds allocated and which organisations received them is set out in Appendix 1.

RECOMMENDATION:

It is recommended that the PCC endorse the allocation of funds from the first round of the Safer Norfolk Foundation Medium Grant Programme.

DETAIL OF THE SUBMISSION

1. KEY ISSUES FOR CONSIDERATION:

- 1.1 Section 9 of the Police Reform and Social Responsibility Act 2011 sets out that a Police and Crime Commissioner (PCC) may make a Crime and Disorder Reduction Grant to any person. A Crime and Disorder Reduction Grant is a grant which in the opinion of the PCC, will secure, or contribute to securing, crime and disorder reduction in the PCC's Local Policing Area. The PCC may make the Crime and Disorder Reduction Grant, subject to any conditions, which the PCC thinks appropriate. The PCC's Crime and Disorder Reduction Objectives are set out within the Police and Crime Plan.
- 1.2 In January 2014, the Police and Crime Commissioner (PCC) launched the Safer Norfolk Foundation Medium Grant Programme (<u>Decision Report 2013/31</u> refers) as one of the ways to deliver grants to organisations in support of the Police and Crime Plan Objectives. The fund, managed and administered by the Norfolk Community Foundation, was set at £100,000.
- 1.3 The first round of bids was invited from charities, voluntary and community organisations across Norfolk, asking them to demonstrate how they could help reduce crime and support victims in their local area in the following areas:
 - Tackling domestic abuse and sexual violence
 - Supporting victims and preventing victimisation
 - Working with offenders to prevent reoffending and rehabilitate offenders
 - Support people with mental health issues and personality disorder, to prevent offending and victimisation
 - Working with young people to help them stay clear of crime
 - Supporting minority communities and improving community relations

The grant programme sought to encourage partnership working and extra weight was given to applications demonstrating where organisations were working in partnership. Grants would be up to a maximum of £10,000 and applications had to demonstrate how the proposed project would make a clear and measurable difference to one or more of the strategic aims of the funding.

1.4 A total of 42 bids for funding were received and on 1st May 2014, the Safer Norfolk Foundation Panel met to review each application against the PCC's priorities. The Panel comprised:

1.6 A breakdown of the funds allocated and which organisations received them is indicated in Appendix 1.

2. FINANCIAL IMPLICATIONS:

2.1 The bids received during the first round were very strong and as a result of this, the initial £100,000 funding pot was increased to £180,000. The additional funding can be met from the Commissioning budget.
