SUMMARY:

- 1. A national collaboration agreement has been drawn up, to which all local policing bodies and chief officers of police, together with the College of Policing and British Transport Police are parties, in relation to the extension and running of the modern slavery police transformation programme.
- 2. The Police and Crime Commissioner (PCC) is now required to agree to enter into the collaboration agreement and authorise his Chief Executive to execute it on his behalf.
